Senior Centers are at the core of CBN's work. Operating 4 centers in East Harlem, the Upper East Side, and Roosevelt Island, CBN serves a culturally diverse population. The Leonard Covello Senior Program in East Harlem was designated an innovative senior center in 2013 by the NYC Department for the Aging, recognizing the high quality and extensive programming provided. While these neighborhoods are socioeconomically disparate, the seniors CBN serves across its centers are typically low to moderate income and vulnerable, adjusting to financial challenges, diminishing health, and a tapering of social networks. Food insecurity is a common denominator. As such, CBN's centers provide 300,000 meals annually through congregate and home-delivered meal programs, addressing both nutritional and socialization needs.

CBN also has a robust social services program, serving clients through its senior centers, offices, and through home visits. Ongoing case management offers clients comprehensive services including assistance with benefits and entitlements, advocacy, counseling, money management, end-of-life planning, and monthly support/discussion groups. 18,190 contacts were made with clients in the last fiscal year to conduct these activities. Through its Community Elder Mistreatment & Abuse Prevention Program (CEMAPP), designed to combat elder abuse, over 3,900 hours of case assistance were provided to clients throughout Manhattan to offer individual counseling, assistance with security device installation, legal advocacy, and safety planning.

The arts are central to CBN's programming. CBN's signature Making Art Work (MAW) program offers classes in painting, ceramics, printmaking, sewing, quilt making, clothing construction, mixed media, dance, and choir. These interactive classes involve long-term projects that keep participants engaged and develop their artistic skills. In 2018, CBN offered over 2,100 art classes through its 4 centers. The Carter Burden Gallery was created to give a voice to re-emerging older professional artists. There were 35 exhibitions last year, featuring the work of 78 artists. 102 pieces were sold, generating \$67,189 in sales.

Carter Burden Network promotes the well-being of seniors 60 and older through a continuum of services, advocacy, arts and culture and volunteer programs, all oriented to individual, family and community needs. We are dedicated to supporting the efforts of older people to live safely and with dignity.

Form 990, Part III, Line 4d - Other Program Services Description

CBN's adult day programs - C.V. Starr and Metro East 99th Street - provided adult day programming in East Harlem. Both programs concluded in December 2017. C.V. Starr was a social model day program offering a full day of therapeutic and recreational programming for older adults experiencing memory impairment or physical frailty. Addressing isolation for adults living at home, the program offered opportunities for socialization and stimulation, as well as respite for caregivers. Metro East 99th Street was New York's first innovative adult day program providing housing and care to chronically-ill long nursing home stay residents who transitioned into community living in an affordable housing development. Though the program closed, it was very successful in helping participants develop critical independent-living skills and supporting their transition to community living from previously unstable housing conditions. The program, and in particular its telehealth component, resulted in significant reductions in hospitalizations as well as significant reductions in healthcare costs for participants.

Volunteers are a critical resource for nonprofits, providing services that enhance programming, address client needs through expertise and care, and expand organizations' capacity. With 3,500 dedicated volunteers, CBN has built a volunteer network that enables more efficient and comprehensive service for 5,000 seniors each year. Last year, volunteers contributed 32,000 hours (equivalent to over \$934,000)
